With the introduction of the General Data Protection Regulation (GDPR) in May 2018, the European Union (EU) has set new binding standards for data protection. GDPR, together with the ePrivacy Directive, ensures the protection of personal data of natural persons (informational self-determination) and applies, with a few exceptions (e.g. police, secret services), to all organizations (authorities, companies, clubs, associations) that process personal data of natural persons.

While large international companies with their own data protection officers, lawyers and IT specialists have the resources to implement and maintain data protection in accordance with the GDPR by themselves, SMEs or clubs and associations generally have neither the necessary know-how, time nor resources to do so at affordable costs.
